Presidents Report:

My background-

I started with 100 Mile MHA in the fall of 2003 as a new U7 parent. I got involved because no one gave us any information or direction. I was brand new to the community and new to hockey. I quickly became the division coordinator so that I could help so that new parents didn't have the same experience that I did. The following season in 2004, became a Director on the Board. I have held team manager positions, HCSP, Division Coordinator, Score/Timekeeper, Off-Ice Trainer and continued to be a Director, a Secretary, North Central District Board Member (16 years now) and in 2007, became 100 Mile MHA President. This role is not new to me. I've sat through many Board Meetings, Finance Meetings, Discipline Meetings, BC Hockey Meetings, and District Hockey Meetings all in the name of

fairness for ALL players. To learn all that I could. 3 of my 4 kids played recreational level hockey here. My Stepdaughter played U18 Female Rep in Williams Lake. My Oldest son aged out in 2014 and after that, I continued to be Team Manager for teams that I had no children on. In 2009, I was hired as the Administrator and held that position until last December. I understand change. Let's all move on.

My motivation is simple-I'm here for the kids-for ALL players and their families to have a safe, fair, and enjoyable MH career. I expect since you have all been acclaimed or elected to your positions, that you share the same goal as I do-to be here for ALL players. Sometimes you will need to make decisions that might affect your own child or friend's child-either positively or negatively; but as a Board Member representing the 200+ players and their families, it's up to you to put your personal agendas aside and be open to the bigger picture in making those decisions. For ALL players and at all levels. In their best interests.

I also wish to remind you all those discussions and decisions made in this room, outside of minutes published, are considered CONFIDENTIAL and should not be shared with the membership. If you are not happy with something, Come TO ME! There is one thing that I cannot stand is chatting outside this room and complaining about decisions made. You are part of those decisions. We are all adults-school yard banter has no place on this Board of Directors. My door is always open. My phone and e-mail checked continually.

I also want to see these meetings go no longer than 2 ½ hours. We all have lives outside of this arena. Having marathon meetings cause resentment within the Board and an unwillingness to stay involved.

NCD AGM-

Marie and I attended the NCD AGM on Sunday, May 7th in Quesnel.

There are 2 notable changes to the NCD Board for the coming season.

Allan Bristowe did not allow his name to stand as President after 2 years due to family health issues.

Jolene Hemming (previous VP from Quesnel) was acclaimed as new President.

Mike Rispin (from Williams Lake) has returned as VP. He is also the District Discipline Chair and Chairs the NC Conflict Resolution Committee.

I am Secretary and Marie is a Director with the Female Hockey portfolio.

We have a young Official heading up the NCO with Rachel Garden (both from PG). His name is Caden Fanshaw. Marks name and e-mail have been forwarded to them.

Went over what BCHL (Junior A League) leaving Hockey Canada at the end of May 2023 means for players and officials. This was also discussed during the Members call on May 10th. MHA Officials should be advised NOT to officiate any UNSANCTIONED games (HSL/BCHL) as this may affect their opportunities to advance through the BCH and HC systems. Basically, if you are registered in the HCR, you are NOT TO participate in these leagues. Banned 1 year. Can re-apply. The HC Bulletin A1915 (HC policy 9.6) still in effect for UNSANCTIONED LEAGUES. BCH and HC want to keep the player pathway OPEN. BCHL is still a member of BCH as of now.

Spoke more about the MALTREATMENT Policy and edits to it that will be coming.

I spoke to Mike Simpson from Merritt. Chair of the TCSL Committee. He doesn't have a definitive answer as far as whether the recreational flight system will continue with adjustments; but suspects that KMHA will not participate in the league. A decision should be made by the end of May at the OMAHA AGM. Some speculation that if the flights go ahead, that October will be the month to have the seeding weekends. Speculations that No league games until November.

The BCH Membership and Society Annual Report have both been submitted.

Just a clarification on player registrations for 2022-2023...we had 214 registered players.
